Coronavirus advice to Students, Parents and Teachers

Introduction

This notice includes updates from the Department of Education and Training as of 29 January on the emerging outbreak of novel coronavirus. Please note that the situation continues to evolve and we will circulate further information when it becomes available.

Background

Cases have been reported predominantly in the city of Wuhan, in the Hubei province of China, as well as in other Chinese cities and in other countries, including at least two confirmed cases in Victoria at the time of writing.

The Department of Education and Training continues to consult Victoria's Chief Health Officer and the Commonwealth Government's Chief Medical Officer and our school follows the Department's advice.

The Latest Department of Education advice (from 29 January 2020

"Parents/guardians/carers of students should ensure that any returning student is isolated at home and should not attend school for 14 days:

- following exposure to any confirmed novel coronavirus case; or
- after leaving Hubei Province.

This same advice applies to any staff who have returned or are returning from Hubei province.

The Chief Health Officer's current advice is that staff and students do not need to be isolated at home if they have recently travelled in other parts of China or other countries and are not showing any symptoms of the virus.

If you think a student or staff member is showing relevant symptoms, please ask the student's parents/guardians/carers or the staff member to call the Department of Health and Human Services (DHHS) to discuss further actions on 1300 651 160."

The school also requests that parents and teachers make contact with the relevant centre Supervisor or Area Manager if an affected student needs support.

Maintaining good hygiene at school and at home

Students and staff are advised that everyone can protect against infections by practising good hand hygiene and respiratory hygiene.

- cover your mouth and nose when coughing and sneezing with a tissue, or cough into your elbow
- dispose of the tissue into a bin and then wash your hands afterwards
- wash your hands regularly, after using the toilet, and before eating.

VSL Centre offices will have health promotion materials to distribute and promote to staff, students and families, namely:

- "Cover your cough and sneeze" poster
- "Be a soapy hero" poster

International Students

International Students need to work closely with their host school staff and with their homestay families who are hosting international students from Wuhan City or other areas where the virus has been reported so that they know how to seek medical advice where appropriate.

Unwell students and staff

In accordance with the Department's regular "Infectious Diseases Policy" send unwell students or staff need to be sent home. Unwell students and staff should remain at home until symptoms resolve and seek medical assistance as required.

In the event that a parent is not aware of the advice from health authorities, and a student arrives at school who should be excluded, the following steps should be taken:

- 1. Reassure the student if they are anxious.
- 2. Move the student to a single room away from others, being mindful of the student's wellbeing.
- 3. Contact parents/carers, inform them of the advice from health authorities and ask them to come and collect their child

The emergency affects everyone and we all need to be diligent and work together to ensure the health and wellbeing of our school community. VSL updates will be placed on our school website whenever the Department of Education and training provides new advice.

Frank Merlino Principal In accordance with national public health guidelines and current information about the coronavirus from the Commonwealth Chief Medical Officer, exclusion of well children or staff from school who have travelled to Wuhan, China, or any other areas where there have been reported cases is NOT required, unless the following applies:

- the person is a confirmed case of novel coronavirus; or
- the person is a close contact with a confirmed case of novel coronavirus in the past 14 days.

If schools think a student or staff member may meet one of the above criteria, please contact the Department of Health and Human Services to discuss further actions via phone: 1300 651 160. Please also inform the Department of Education and Training by making an IRIS incident alert.

If a student or staff member is sick with symptoms such as fever, cough, shortness of breath or sore throat within 14 days of being in Wuhan, China or other countries with cases:

- The student or staff member will need to be excluded from school until reviewed by a doctor
- Where necessary, call the student's parents or guardian to inform them of the need to exclude the child for medical review
- If the school is arranging transport for a student or staff member to a medical facility, call ahead to inform them the patient has been in Wuhan, China, or another country with cases and ensure the travel history is given to the facility on arrival.

If the student or staff member has severe symptoms, such as shortness of breath:

- Call 000 and request an ambulance, and
- Inform the paramedics that the patient has been in Wuhan, China.

Dear colleagues,

You will be aware of the emerging outbreak of novel coronavirus. Cases have been reporte predominantly in the city of Wuhan, in the Hubei province of China, as well as in other Chine se cities and in other countries, including at least one confirmed case at the time of writing in Victoria Australia.

The Australian Government has advised that there is no cause for alarm with respect to the coronavirus and that the risk to the Australian public remains relatively low.

The Department of Education and Training has consulted with Victoria's Chief Health Office and Department of Health and Human Services to provide the following advice to schools and Ic al communities:

Remind your staff and students that everyone can protect against infections by practising good hand hygiene and respiratory hygiene. Cover your mouth and nose when coughing and sneezing with a tissue, or cough into your elbow, dispose of the tissue into a bin and then wash your hands fterwards. Wash your hands regularly, after using the toilet, and before eating.

Health promotion materials are available to distribute and promote to your staff, students ar | families, see:

- Be a Soapy Hero!

If you are an International Student Program school, work closely with your homestay familie who are hosting international students from Wuhan City or other areas where the virus has been reported so that they are assured of the relatively low risk and know to seek medical advice where apprinter. For information you may wish to provide to your homestay families, see: Information for the pub connavirus

Exclusion of well children or staff from school who have travelled to Wuhan, China, or any coner areas where there have been reported cases is **NOT** required, unless the following applies:

- the person is a confirmed case of novel coronavirus; or
- the person is a close contact with a confirmed case of novel coronavirus in the past 4 days.

If you think a student or staff member may meet one of the above criteria, please contact th Department of Health and Human Services to discuss further actions via phone: 1300 651 ⁺ 30. Please also inform the Department of Education and Training by making an IRIS incident alert.

For staff and students who experience flu-like symptoms **AND** have recently travelled to Wu nan City, Hubei province, or had close contact with a confirmed case:

- seek medical advice for any staff or students in your care who experience fever and symptoms (including but not limited to cough, sore throat, shortness of breath, body aches or fatigue) **AND** have recently travelled to Wuhan City or had close contact with a confined case in the 14 days before of the onset of illness. Call ahead to notify the medical practition of recent travel; and
- contact the Department of Health and Human Services on 1300 651 160 and inform the Department of Education and Training by making an IRIS incident alert. The Depart tent of Education and Training will ensure appropriate support is provided.

Continuity of learning

Schools should support students who are unable to attend school by providing educational materials that can be completed at home. The Department is working with Virtual School Victoria in preparing further educational resources to assist schools and these will be made available next week.

International Student Program

The Department is working to support the small number of schools hosting students from Hubei Province, China.

If you are an International Student Program school, work closely with your homestay families who are hosting international students from China or other areas where the virus has been

reported so that they are assured of the relatively low risk and know to seek medical advice where appropriate.

It is important that you closely monitor the wellbeing of international students, particularly from China, who may feel vulnerable at this time, and connect them to support services as required.

International travel

Schools are reminded to monitor the travel advice level from the Department of Foreign Affairs and Trade (DFAT) through the SmartTravel website.

The Department's <u>Overseas Travel Requirements</u> and <u>Travel Policy</u> provide advice on the action schools should take at each advice level.

Approval for travel to countries and areas identified as 'Do not travel' or 'Reconsider your need to travel' locations by DFAT must only be given after careful consideration of the risks involved in travelling to such destinations.

For early childhood education services

Attendance

This recommendation is that parents/guardians/carers of children should ensure that any child is isolated at home and should not attend their service for 14 days:

- following exposure to any confirmed novel coronavirus case; or
- after leaving Hubei Province.

This same advice applies to any staff who have returned or are returning from Hubei province.

The Chief Health Officer's current advice is that staff and children do not need to be isolated at home if they have recently travelled in other parts of China or other countries and are not showing any symptoms of the virus.

- 3. Contact parents/carers, inform them of the advice from health authorities and ask them to come and collect their child

If you think a student or staff member is showing relevant symptoms, please ask the student or the staff member to call the Department of Health and Human Services (DHHS) to discuss further actions on 1300 651 160.

If you think a student or staff member is a confirmed case or a contact of a confirmed case, please contact the Department of Health and Human Services to discuss further actions via phone: 1300 651 160.

In the event that one of your staff or students is not aware of the advice from health authorities, and arrives at a TAFE or training provider who should be excluded, the following steps should be taken:

- 1. Reassure the person if they are anxious

- 3. Inform the person of the advice from health authorities and ask them to seek immediate medical attention
